



## Africa Climate Change Resilience Alliance (ACCRA): Helping policy-makers understand rural adaptation

The Africa Climate Change Resilience Alliance (ACCRA) is run by a consortium of International NGOs, including ODI. Its aim is to improve the design and delivery of humanitarian and development interventions so that they increase the adaptive capacity of poor and vulnerable communities. Through an extensive research process, capacity building and policy-relevant work carried out between 2009 and 2011, ACCRA successfully influenced relevant policies and plans at the national level in three targeted countries - Ethiopia, Mozambique and Uganda, bringing together key government institutions responsible for Disaster Risk Reduction (DRR) and climate change, and significantly increasing the capacity of government stakeholders to understand and address climate-related challenges.

Following on the successful outcome of the first phase of the project, CDKN has agreed to a no-cost extension to the project. ACCRA's second phase will focus on one particular characteristic of adaptive capacity: "flexible and forward looking decision-making". More specifically, the following research questions will be addressed:

- How can planning be more 'forward looking' and take into account change and uncertainty?
- How can planning at local level inform higher level planning and allocation of resources and take more account of institutions and power, and build agency?

This research agenda will thus also investigate the type of participatory processes, information and analysis that are required at the community level for planning purposes, as well as the approach that would help planners understand and support institutions fostering adaptive capacity.

<ul> <li>Research impact</li> <li>The project has already produced a total of 27 written publications across a wide spectrum of outputs. As part of this, two ODI-led Working papers furthered understandings of adaptive capacity and resilience, and increased the visibility of ODI researchers on these themes.</li> <li>Governments used the research findings as baseline information for planning policies and strategies. The programme was also the driving force behind the first ever seasonal forecast in Uganda; broken down in different languages and communicating messages around variability and adaptation across the whole country.</li> <li>In Ethiopia and Mozambique national planners and finance leaders have been using evidence and best practice generated by the programme to do things differently. In Ethiopia national officials are rolling out training across 56 <i>woredas</i> (districts) based heavily on ACCRA training materials. The same is happening in Mozambique where new adaptation finance is flowing; national agencies are using ACCRA information and idea to inform their practice and policies.</li> <li>Under Phase 2 of ACCRA, the research component will seek to evaluate the success of an ACCRA game, which will be applicable to a district government context and specifically tailored to each of ACCRA's three countries: it will be first tried in Uganda (Oct 2012), and then repeated in Mozambique and Ethiopia (Jan/Feb 2013).</li> <li>Combination of approaches to adaptation – different disciplinary perspectives and groups of people working in disasters, adaptation and development planning brought together conceptually and in practice.
