- 2. First-hand experience on process understanding on assessment of community level vulnerabilities, sectoral gaps and scope of integration of CCA & DRR is departmental plan development and execution.

Background



We live in a state which is considered to be the largest populated state of the country. Apart from the most populated Uttar Pradesh is spread in nine different agro climatic zones prone to different natural hazards such as flood, drought, earthquake and fire. Floods are repeated events in eastern part of the state which is largely linked with changing climatic scenario. Climate variability can be observed directly here in the form of heavy and uneven precipitation causing devastating floods and water logging in large area of the region. Flood always bring loss of human lives, damage to livelihoods, loss of natural resources and direct impact on overall economy. It does not differentiate between rural and urban but there are probable intense vulnerabilities in the cities where unplanned development and rapid construction has increased risk of flood and water logging. Direct relation of climate change with disasters has made us working for mainstreaming climate change issues in disaster risk reduction strategies at

district as well as at state level. It has already been integrated at national level through India's commitment to Hyogo Framework for Action (HFA 2005-15). National level action plan has come into existence with various missions like sustainable habitat mission and others but at state and district level lack of capacities of various departments and agencies are the major challenges we have to face in order to bring a climate and disaster resilient model of development. Considering climate change component, District Disaster Management Authority (DDMA) in the district is responsible for making an effective district disaster management plan (DDMP) for better response during and after disaster. But lack of capacity and orientation on the issue usually obstructs the process.


